ORDER

Desh Deepak Adarsh Mahavidyalaya, Tenduamafi, Bikapur, Faizabad, Uttar Pradesh submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grant recognition to Desh Deepak Adarsh Mahavidyalaya, Tenduamafi, Bikapur, Faizabad, Uttar Pradesh for an annual intake of 100 seats (One Hundred only) in B.Ed. course of One year duration with effect from September 15, 2004 subject to compliance of the following conditions before the commencement of the academic session.

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 50 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 DESH DEEPAK ADARSH MAHAVIDYALAYA, VILLAGE - TENDUA MAFI, POST - BIKAPUR, TEHSIL - BIKAPUR, DISTT. - FAIZABAD, U.P. has submitted an application (code No. Ann03479) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.P.Ed. course of One year duration with an annual intake of 50 (Fifty only) students on 29.12.2006.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report - : ideography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary -PE such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to DESH DEEPAK ADARSH MAHAVIDYALAYA, VILLAGE - TENDUA MAFI, POST - BIKAPUR, TEHSIL - BIKAPUR, DISTT. - FAIZABAD, U.P. for conducting B.P.Ed. course of Secondary -PE (level) of one year duration with an annual intake of 50 (fifty) students from the academic session 2008-2009 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following conditions:

- (i) The admission in the institutions so recognized for the academic session 2008-2009 shall be made only after affiliation by the examining body, before the commencement of the academic year and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic year 2008-2009, failing which the recognition will be deemed to be for the next academic year i.e. 2009-2010.
- (ii) Formal orders for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/affiliating body. The decision of the University in this regard shall be final.
- (iii) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (iv) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (v) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

ORDER

WHEREAS, in terms of section 15(1) of the NCTE Act, 1993, Desh Deepak Adarsh Mahavidyalaya, Vill- Tendua Mafi, Post- Bikapur, District- Faizabad, Uttar Pradesh has submitted an application to the NRC for grant of recognition/permission for conducting M.Ed Course of one year duration with an annual intake of 35 (Thirty-five only) seats on 31.10.2008.

AND WHEREAS, the inspection of the institution u/s 15 was conducted on 28.08.2009.

AND WHEREAS, the VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 149th Meeting held on September 13-14, 2009 and the committee decided to issue Show Cause Notice. Accordingly, Show cause notice issued to the institution on 25.09.2009 on the following grounds:-

- Ten computers are not enough for students of all courses.
- Titles of Books are not as per Norms for M.Ed course.
- Journals, encyclopedia and e-learning materials are not available.
- Psychology lab is ill equipped.
- No proper furniture is available in Computer lab.
- No furniture is available in science lab.
- Playgrounds are not developed.

AND WHEREAS, reply received was placed in the 151st Meeting held on October 20-21, 2009 and the committee decided not to process M.Ed. file of this Institution. Accordingly, refusal order issued to the institution on 04.12.2009 on the following grounds:-

- As per Norms & Standards for M.Ed., only Institutions running B.Ed. programme are eligible to offer M.Ed. course except University Departments which may not be directly running a B.Ed. programme.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 28.01.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 12.04.2010 accepted the appeal and set-aside NRC's order dated 04.12.2009 and remand back the case to NRC for further processing on merits, as per regulations, as the institution was already running B.Ed. programme.

AND WHEREAS, the appeal order was placed in the 159th meeting held on April 28-May-01, 2010 and it was decided to issue letter under clause 7(9) of regulations 2007. Accordingly, Letter of intent prior to recognition issued to the institution on 11.05.2010.

AND WHEREAS, the reply of the institution dated 20.08.2010 has been considered in its 171st Meeting held on October 28-29, 2010 and it has been decided to seek clarification from the institution. Accordingly, letter issued to the institution on 18.11.2010 on the following points:-

- The faculty has been appointed after taking due process of selection and approval of the university has been obtained. However, Dr. Krishna Dev Tiwari, appointed as Reader does not possess the required 3 years experience and teaching at M.Ed. level.

AND WHEREAS, the matter was placed in the 177th Meeting held from January 27-29, 2011. The reply dated 16.12.2010 received consequent upon the issue of clarification letter dated 18.11.2010, by Principal of the college be accepted, as Shri Tiwari possess required experience of teaching M.Ed. classes.

Hence, NRC decided to issue formal recognition order for M.Ed. course with an intake of 35 seats under clause 7(11) and in terms of section 15(3)(a) of the NCTE Act, 1993 subject to the usual terms and conditions.

AND WHEREAS, the NCTE has issued letter No.48-S/PT-III/ NCTE (N&S) dated 31.08.2010 in which it was stated that the matter regarding issue of recognition order under clause 7(9) or 7(11) of NCTE Regulations to the institution which were found eligible for grant of recognition order on merit but where order could not be issued due to the ban imposed by the NCTE on 26th July, 2009 has been considered by the Council and it is clarified that such pending orders now be issued. This is due to the consideration that the present ban is only on fresh receipt of application for the academic session 2011-2012 and therefore the old pending cases are to be disposed on merit without any reference to the ban.

AND WHEREAS, the above letter of NCTE, Headquarter was considered by NRC in its 166th Meeting held on 9th September, 2010 and NRC decided that the recognition order under section 7 (11) of NCTE, Regulations in all such pending cases where NRC or Council (NCTE) had decided to grant recognition under section 7 (11) of NCTE Regulations by lettered from the session 2010-2011 subject to the following condition:-

- The admission of students shall be

- The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.
